



Infusion® LED Module Limited Warranty

Applies to GE Infusion® LED Modules purchased directly from GE between March 1, 2015 and the date on which this Limited Warranty document is later superseded.

GE Lighting ("GE"), a business of General Electric Company, is pleased to provide the following limited warranty covering GE Infusion® LED Modules purchased directly from GE after March 1, 2015 and until this Limited Warranty document is superseded. This Limited Warranty covers GE Infusion® LED modules operated with a driver from the Approved Driver List for GE Infusion LED Modules when operated within the approved temperature limits as stated in the Infusion® LED module application guide and installed in accordance with GE's written installation instructions for the Infusion® LED module.

GE warrants that Infusion® LED modules comply with GE's published specifications and are free from defects in materials and workmanship that result in a failure to operate (i.e. a failure to light) for the period of time set forth below.

Remedy: If a GE Infusion® LED module fails due to defects in materials or workmanship within the earlier of five (5) years after the date of manufacture and 22,000 hours of operation, then GE will, at its option, either (i) provide a free replacement module to the direct purchaser ("Purchaser") that is the same or comparable to the original product, or (ii) provide a credit to Purchaser equal to the current price GE charges Purchaser for the module. This warranty applies only to GE Infusion® LED modules that are operated with a driver from the Approved Driver List for GE Infusion® LED Modules and are properly wired and installed together as a system; operated within the approved temperature limits as stated in the Infusion® LED module application guide and installed in accordance with GE's written installation instructions for the Infusion® LED module; operated within the electrical values shown on the module label; and operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the system. Any replacement Product or part will be comparable in function, but may not be identical to the original. The replacement or repaired Product is warranted for the remainder of the original warranty period. GE is not responsible for labor and other costs associated with removal or reinstallation.

Terms & Conditions: The foregoing GE Infusion® LED module warranty applies only to direct purchases from GE, but does not apply to failures caused by acts of God or as a result of any abuse, misuse, abnormal use, or use in violation of any applicable standard, code or instructions for use in installations, including, but not limited to, those contained in the National Electrical Code (NEC), the Standards for Safety of Underwriters Laboratory, Inc. (UL), Standards for the International Electrotechnical Commission (IEC), Standards for the American National Standards Institute (ANSI), in Canada, the Canadian Standards Association (CSA), in Europe (CE), or in Australia (C-Tick). This warranty will not apply in the event of conditions demonstrating abnormal use or stress, including under/over voltage conditions, excessive switching cycles and operating hours. Replacement of the GE Infusion LED module with LED light components of other manufacturers will void entire warranty. Replacement of the LED driver from the Approved Driver List for GE Infusion LED Modules with a non-approved driver will void the entire warranty. *GE reserves the right to examine all failed GE Infusion LED modules to determine the cause of failure and patterns of usage* and reserves the right to be the sole judge as to whether any module or any of its components are defective and covered under this warranty.

THE FOREGOING WARRANTY CONSTITUTES THE SOLE AND EXCLUSIVE REMEDY OF PURCHASER AND THE SOLE LIABILITY OF GE FOR CLAIMS BASED ON DEFECT IN OR FAILURE OF PRODUCTS, WHETHER THE CLAIM IS IN CONTRACT, INDEMNITY, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE . THESE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER WRITTEN, ORAL, IMPLIED OR STATUTORY. NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED. IN NO EVENT SHALL GE BE LIABLE FOR ANY OTHER COSTS OR DAMAGES INCLUDING LOST PROFITS, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES.

To Make a Warranty Claim: To make a warranty claim, retain the failed products and notify your GE sales representative in writing within thirty (30) days of the failure. This warranty extends only to Purchaser. However, GE will honor, under the terms of this Limited Warranty, valid warranty claims made by Purchaser for the remedy set forth above as a result of warranty claims made to Purchaser by its customers and indirect customers.
